Pr JEAN-SÉBASTIEN BORGHETTI studied business administration and finance at HEC Paris before earning a PhD in law at the Sorbonne. He has been a professor at Paris-Panthéon-Assas University since 2009. Jean-Sébastien specializes in contract and tort law, in a comparative perspective. He also practices arbitration, both internal and international, and has been teaching contract law to arbitration lawyers for several years. He has been invited to teach in several countries, including the United States, and was a member of several commissions working on the reform of French law. He speaks French, English and German fluently. He teaches the “Assessing Damages in International Arbitration” course in the LLM AWArDS.

JACOB GRIERSON focuses on International Arbitration. He represents clients from numerous countries in a broad range of international arbitrations. He has handled arbitrations in all of the major places of arbitration, although predominantly in London and Paris. He has co-authored numerous articles and handbooks on arbitration, including *Arbitrating under the 2012 ICC Rules: An Introductory User’s Guide*, published by Kluwer Law International, and is a visiting professor (chargé de cours) at the College of Europe in Bruges, the University of Versailles, the University of Paris-Assas and the University of Paris Est-Créteil. He teaches the “Conduct of arbitral proceedings” course in the LLM AWArDS.

Pr PIERRE MAYER acts as arbitrator or counsel in commercial and investment treaty-based proceedings under a variety of ad hoc or institutional arbitration rules. His experience spans a variety of sectors (including energy, transport, telecommunications, projects, M&A, etc.) and all forms of contracts. He is one of the most highly regarded arbitration practitioners in France (Who’s Who Legal Arbitration in France 2018) and is routinely acclaimed as one of the best arbitrators in the world.

Dr NATHAN TAMBLYN is Associate Professor of the Common Law at the University of Exeter Law School. Nathan is a Fellow of the Chartered Institute of Arbitrators, a member of the London Maritime Arbitrators Association and the London Court of International Arbitration, and a Panellist at the Singapore Chamber of Maritime Arbitration. Nathan is a lawyer in the commercial and common law team at the Law Commission of England and Wales, and is leading its project reviewing the Arbitration Act.

Pr MALIK LAZOUZI is the founder of the LL.M. AWArDS. He has published extensively about investment arbitration, international commercial arbitration and international business litigation. His recent engagements include teaching international commercial arbitration in Dubai, Mauritius, Notre Dame University Law School (2023); giving a special course (2019) and the general course (2022) at the Arbitration Academy. He has also been recently a guest speaker at conferences dedicated to international arbitration (King’s College London, etc.).
